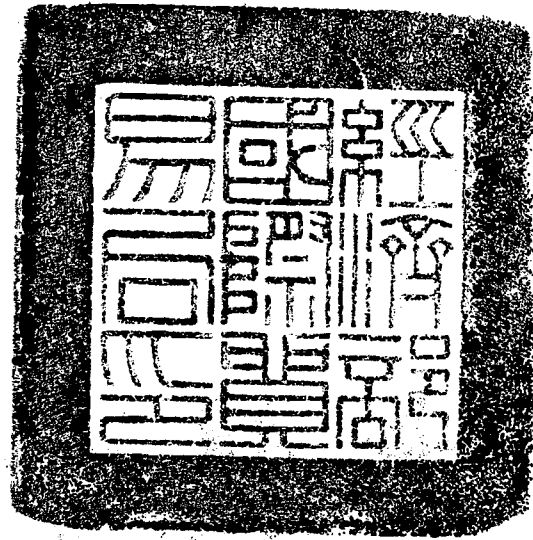

主旨：公告修正CCC2924.29.10.00-4「非納西汀（對乙氧基-乙醯苯胺）」等94項貨品之複合輸入規定代號內容，列入「海關協助查核輸入貨品表」，並自即日起實施。

依據：貨品輸入管理辦法第8條第1項、財政部關務署本(104)年6月17日「104年海關與各簽審機關聯繫會議」提案3會議決議、行政院農業委員會本年8月6日農際字第1040062728號函、本年9月9日農際字第1040062842號函、行政院農業委員會動植物防疫檢疫局本年8月21日防檢五字第1041500100號函、本年9月10日防檢五字第1041500311號函、衛生福利部本年8月10日衛部中字第1041840989號函、本年9月8日衛部中字第1041841189號函、衛生福利部食品藥物管理署本年8月10日FDA北字第1049019710號函、本年9月17日FDA北字第1049023719號函、行政院環境保護署本年8月21日環署毒字第1040068314號書函及財政部關務署本年9月14日台關業字第1041020958號函。

公告事項：

- 一、鑒於產品應用層面日趨多元，進口貨物申報用途如非屬複合輸入規定明文列管之用途者，易衍生是否控管之疑義，爰修正「802」等11項複合輸入規定代號之內容，俾利海關於邊境依法協助主管機關貨品管理。

Importation of medical devices for human use must be handled according to the following regulations: (1) A photocopy of the medical devices pre-marketing license or an approval document issued by the Ministry of Health and Welfare should be submitted. In addition, the number of the pre-marketing license (consisting of 14 letters and digits) must be declared and listed in the import declaration . (2) If the medical devices being imported are dangerous, then besides the photocopy of the medical device pre-marketing license and the license number declared and listed in the import declaration, an approval of the medical institutions/facilities procurement from the Ministry of Health and Welfare is also required. 2. Importation of medical devices which are not for human use are exempted from the above regulations.
